

## John Bauer Story

### The Restoration Began on Sunday October 3<sup>rd</sup> 2004



.....and here we are some 6 years later and our '69 Road Runner is still incomplete. I wrote the first article on the restoration process in January of 2004 with the hopes of having it completed by the 2004 Mopar Nationals. I was either dreaming or smoking some “wacky tobacky” when I came up with that date but we all know that the best laid plans sometimes go south.

The first body shop did a little bit of the work in 2005 but then just sat for a long time so I loaded her on the trailer and put her in storage. However, Paul Jacobs of Jacobs Restoration continued the restoration work on all the various components like the suspension, dash, steering column, bezels, trims, etc., etc. and I began buying my new parts from all the major restoration suppliers which finally ended up under all three of our beds, in my office, in the attic and in the garage and not for just a few weeks or months but for 4 years.

Carol Ann was very understanding and extremely patient with the whole restoration process but at times I'm sure she wished I never had the tools to disassemble a car. However, we didn't have to sweep under any of the beds as there was no room for dust to gather on the carpet. Well that was my thinking but certainly wasn't “Honey's” thinking.

As most of you know I kinda got sidetracked building another car so the Road Runner continued to sit in my sister's pole barn and eventually in our garage until I figured it was time to get started again. My very original plan was to have the body work and paint done locally and then I'd re-assemble the car myself but I spent a few days building Paul's office so we agreed to trade the man hours instead of receiving any payment.


So early this spring I called Troy Angelly (Paul's partner) and asked him to please finish the body work and paint so I could get the car to Paul for final assembly, with my help. All of the parts that Paul restored and shipped to me were loaded into a trailer and re-delivered to Paul's shop and the shell was delivered to Troy's facility. Since this is a somewhat rare numbers matching car it had to be done by a Mopar expert as I want it to mirror the car that rolled off the assembly line in 1969. In hind sight I'm okay with the fact that the first body shop lost interest as I'm sure some of the important details would have been missed by them and me in the process of restoring the car to its original condition since neither of us were restoration experts.

As of this writing (9-27-2010) the car is ready to enter the paint booth where it will receive a W1 (Alpine White) painted top over a F8 (Ivy Green) body which was an unusual paint scheme back in the day. According to the information I received there were only 656 hardtop Road Runners produced in 1969 with two tone paint. I'm very anxious to see her in color and more anxious to see her totally complete as it's been a long ordeal. This is a 383 cu.in. 4 speed, radio delete car and the only options which were ordered was a 3 speed wiper motor, power steering and full wheel covers. I know the car will look strange in comparison to the "standard" Road Runners but I also know the car will be done properly, providing Paul doesn't let me help too much. ☺ Since I haven't been very good in predicting completion dates I will only say that I am cautiously hopeful to have it completed by the 2011 Chrysler Swap Meet at the Indiana State Fair Grounds.

Our plans for the car? I am hopeful there is a collector out there that doesn't have a two tone Road Runner in his stable that would love to have something his fellow collectors do not have. Although I've had fun and learned a lot during the restoration process I don't believe I'll ever take on another project like this one. And Honey said..... AMEN!




**From And About Our Members**



Ken Mosier's 1970 Dodge Challenger has been named Goodguys 2010 Hemmings Muscle Machines Muscle Car of the Year! Mosier, owner of his own restoration shop "The Finer Details" in Danville, Indiana had chased this particular car for over 17 years before recently getting his hands on it, personally restoring it to original factory condition. The numbers matching muscle car is just as spectacular as it was the day it rolled off the assembly line.

This particular Challenger was one of the rare 426 hemi powered R/T models which now bring unbelievable prices at auctions throughout the world. The elephant 426 is equipped with two four barrels and a four point ignition. It's backed by a desirable four-speed with a pistol grip and a 4:10 geared Dana. Brakes for the purple beast are manual drum and the bucket seat/rally dash interior was refinished using products from Legendary Auto Interiors.

Mosier will receive a customized toolbox courtesy of Snap-on as well as his Muscle Car of the Year award while in Scottsdale at the season-ending 13th Southwest Nationals, November 19-21 at Westworld.
